HIV/AIDS has become one of the most formidable public health, human rights and health challenges of modern times. The AIDS epidemic in sub-Saharan Africa has overwhelmed the region and it urgently requires a concerted global effort and private/public cooperation to efficiently implement prevention and treatment strategies.

This symposium seeks to provide answers to these challenges. *The morning session* explores the meaning of the "international right to health" and its usefulness as a tool for making AIDS prevention and treatment available in Africa. Experts will give examples of concrete and workable strategies that can make a difference in the lives of African citizens. The afternoon session focuses on existing barriers to implementation, and explores possible actions to overcome them. The symposium culminates in the development of a "Philadelphia Declaration" in Defense of Health and Human Rights and the Dignity of People living with HIV/AIDS in Africa. Conference participants will join a panel of experts to discuss the provisions that should be included in the "Declaration."
